

FEED. COMPETITION RULES

Article 1. ORGANISING COMPANY AND SUBJECT OF THE RULES

1.1 Feed, a public limited company with share capital of 22 812,62 euros, with address at 231 rue Saint-Honoré 75001 Paris, registered at the Paris Trade and Companies Register under number 821 239 878, hereinafter "Feed." or "the Organiser", will organise a competition called "Voyages Light" from 28/01/2019 to 28/03/2019 that is free of charge upon purchasing an item.

Article 2 CONDITIONS FOR PARTICIPATION

2.1. The game is open to all natural persons of age residing in metropolitan France (including Corsica) who have purchased *Feed. packs. 15, 30 or 60 Light meals*, excluding Feed staff and/or their relatives and individuals who participated in organising the competition and their relatives.

2.2. The organiser has randomly placed three (3) "golden tickets" in the *Feed. Light* packs mentioned below:

- One golden ticket in a 15 meal pack
- One golden ticket in a 30 meal pack
- One golden ticket in a 60 meal pack

The person who finds the golden ticket will win two return tickets from Paris to the destinations mentioned in Article 3, as well as six (6) nights' accommodation.

The competition may only be entered online. The Winner undertakes to make contact with Feed. before 28/05/2019 with the proof of winning (hereinafter the winning ticket). Purchase of a product from the Feed. Light range mentioned in Article 2.2 implies acceptance and compliance with these rules, available for consultation upon purchase from the website.

2.3. RULES OF THE GAME / HOW WINNERS ARE SELECTED

2.4. How to enter:

The competition is free of charge upon purchase of a pack. Natural persons only who have purchased *Feed. Light 15, 30 or 60 meals* online may enter.

2.5. How the winner is selected

2.5.1. The winner will be the entrant who finds a ticket with the words "ticket d'or" (golden ticket) and "félicitations, vous avez trouvé le ticket d'or" (congratulations, you have found the golden ticket) will be the winner in the *Feed. in the Light 15, 30 or 60 meal product pack*.

2.5.2. The Winner should make him or herself known to the organiser by sending a photo or scan of the golden ticket to the address on the winning ticket and call the number on the winning ticket to obtain their prize.

2.5.3. If the Winner fails to contact the organiser by 28/05/2019, he or she will be deemed to have forfeited the Prize and the Prize will remain the Organiser's property.

Article 3. PRIZES

3.1. The Organiser will offer three (3) prizes as follows:

PRIZE 1 FOR THE FEED. 15 LIGHT MEAL PACK. :

- Return flights for two (2) persons exclusively from Paris to Ibiza only
- Airport taxes (included in the airfare)
- Six (6) nights in a hotel of at least 3* in Ibiza

with an indicative value of €1000 including taxes and charges.

PRIZE 2 FOR THE FEED. 30 MEAL PACK. LIGHT

- Return flights for two (2) persons exclusively from Paris to Mykonos.
- Airport taxes (included in the airfare)
- Six (6) nights in a hotel of at least 3* in Mykonos.

with an indicative value of €1500 including taxes and charges.

PRIZE 3 FOR THE FEED. 60 MEAL PACK LIGHT

- Return flights for two (2) persons exclusively from Paris to Miami only.
- Airport taxes (included in the airfare)
- Six (6) nights in a hotel of at least 3* in Miami

with an indicative value of €2500 including taxes and charges.

No other expenses not including in the three (3) prizes mentioned may be paid by Feed. Including but not limited to: Airport transfer costs, costs for travel documents, visas and passports, travel insurance, cancellation insurance (covering cancellation of the trip by the winner), health insurance, tips, additional services requested by the winner, full board ("buffet" breakfast, lunch and dinner at the hotel restaurant) and any excursions will be borne by the winner.

This Prize may not be transferred or split and may not be exchanged for monetary compensation. These tickets are issued in the beneficiary's name. Once issued, the tickets may not be transferred, split, exchanged, modified or refunded. The tickets are non-transferable, whether free of charge or in return for payment. The value of the tickets may not be claimed in cash or exchanged for any other good or service.

3.2. Once attributed to the winners, the Prize is personal, non-transferable and may not be exchanged for cash. No compensation will be payable if the winner does not wish to claim the prize.

- 3.3** The winner's prizes will only be valid for use between 10/09/2019 and 10/12/2019 (last return). No plane tickets or accommodation may be booked outside those dates. Tickets are subject to availability on the given dates.
- 3.4.** The prize will be sent via email. Any mistakes in the name or address of the prizewinner will result in cancellation of the prize.

Article 4 PERSONAL DATA

- 4.1.** The winners authorise Feed. to use their surnames, first names, town or city of residence for advertising purposes, without giving rise to any remuneration, right or advantage or than the Prize. Any objections must be submitted by the winners Feed. as soon as they have received the prize.
- 4.2.** The Organiser is the recipient of the information contained in the Competition. As such, Feed. informs participants that the personally identifiable data collected may be processed automatically and will be stored for a period of three years and may be used during that period. In accordance with the French Data Protection Law 78-17 of 6 January 1978, participants are entitled to access, rectify and delete their personal data. - 5.2.** The Organiser may not be held liable if, for reasons beyond his control, technical problems, IT bugs or any other technical problem affect the organisation of the game or the list of winners. In such cases, claimants may not claim any prize whatsoever.
- 5.3.** Feed. reserves the right to cease, postpone, modify or cancel the competition at any time in which case the participants may not claim any damages.
- 5.4.** Cases not provided for by these rules will be decided on by Feed. whose decisions will be final.
- 5.5.** Furthermore, the Organiser may not be held liable in the event of delivery issues or loss of postal or electronic mail.
- 5.6.** The prizes attributed to the winners may not give rise to any dispute or be exchanged on the request of the winners for cash or any other prize on any grounds whatsoever. The prize may not be exchanged for another prize or paid in cash.
- 5.7.** If any of the information or contact details is incomplete or in violation of these Rules, the Participant's entry to the competition will be invalid, and said participant will not be eligible to win any of the prizes available.

- 5.8.** Entries must be made in good faith: it is specifically forbidden to modify or attempt to modify the game materials, particularly in order to modify the results.
- 5.9.** The Organiser reserves the right to cancel the participation of any Participant who fails to comply with the Rules.
- 5.10.** It is strictly forbidden for any given natural person to play on behalf of any other person.
